**ARTICLE I.  
NAME**

The name of the Limited Liability Company is "A/P, LLC" (the "Company").

**ARTICLE II.  
ADDRESS**

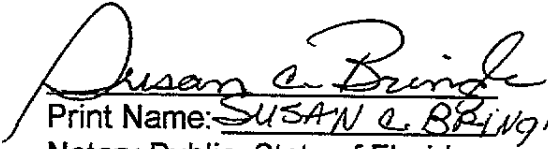
