## ARTICLES OF ORGANIZATION of EVANGELISTA DESIGNS, LLC

a Florida Limited Liability Company

#### ARTICLE I - Name:

The name of this limited liability company is Evangelista Designs, LLC

#### ARTICLE II - Period of Duration:
