## ARTICLES OF ORGANIZATION

OF

### ARTICLE I

#### NAME, PRINCIPAL ADDRESS, AND MAILING ADDRESS

### ARTICLE IV


#### REGISTERED AGENT, INITIAL REGISTERED OFFICE

The members from time to time may move the registered office and/or the principal office to any other address in the State of Florida.


#### ARTICLE V MANAGEMENT




