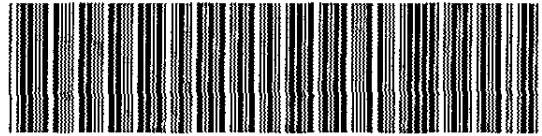

3. The Articles of Organization of the Company are hereby amended by deleting the name, "ALAMAR MORTGAGE AND FINANCIAL SERVICES, L.L.C.", wherever it occurs, and substituting, in lieu thereof, the name "BISHOP LENDING GROUP, L.L.C."
