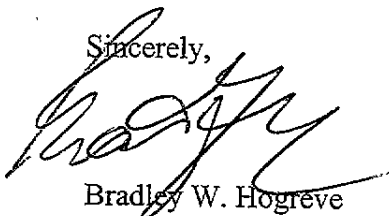

ARTICLES OF ORGANIZATION

THE BIG WENDY, L.L.C.

A LIMITED LIABILITY COMPANY

(Pursuant to s. 607.407, Florida Statutes)

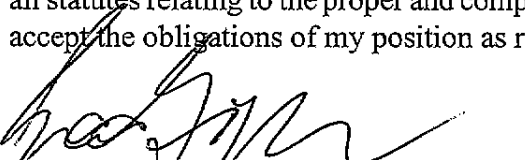
