

ARTICLES OF ORGANIZATION
OF
PATVAL CO., L.L.C.

ARTICLE I — Name:

The name of the Limited Liability Company (hereinafter referred to as the "Company") is "PATVAL CO., L.L.C."

ARTICLE II — Duration:

The Limited Liability Company's period of duration shall be perpetual.

ARTICLE III — Address:

The mailing address and street address of the principal office of the Limited Liability Company shall be 1528 S.E. 12th Court, Deerfield Beach, Florida 33441.

ARTICLE IV — Registered Agent and Address:

The name of the Limited Liability Company's initial registered agent is **GEORGE A. PATTERSON**, and the street address of said registered agent is 1528 S.E. 12th Court, Deerfield Beach, Florida 33441.

ARTICLE V — Additional Members:

The members of the Limited Liability Company may admit additional members by unanimous vote of the entire membership.

**ARTICLE VI — Death, Resignation, Expulsion, Bankruptcy, or
Dissolution of a Member:**

In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company the remaining members of the Limited Liability Company shall continue the Limited Liability Company if, by at least three-fourths majority vote, they elect to do so.

ARTICLE VII — Purpose:

The purpose for which the Limited Liability Company is organized is to transact all lawful business for which companies may be organized under the Florida Limited Liability Company Act.

ARTICLE VIII — Management:

A. The Limited Liability Company is to be managed by the members and the name and address of the present managing member is:


