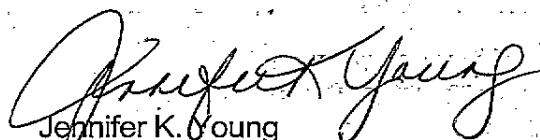

**ARTICLES OF ORGANIZATION

**ARTICLE I. – NAME**
