ARTICLES OF AMENDMENT

TO

ARTICLES OF ORGANIZATION OF

BROADSWEEP TECHNOLOGIES, LLC
(A Florida Limited Liability Company)

BROADSWEEP TECHNOLOGIES, LLC f/k/a TRILIUM COMMUNICATIONS, LLC
(the "Limited Liability Company") desires to amend its Articles of Organization, and pursuant to
Florida Statute 608.411, submits the following:

FIRST: The date of filing of the Articles of Organization was May 2, 2001, effective May 1, 2001.

SECOND: The following amendment to the Articles of Organization was adopted by the
Limited Liability Company:

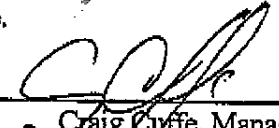
ARTICLE VI of the Articles of Organization shall be replaced in its entirety by the
following ARTICLE VI:

ARTICLE VI - Membership Units

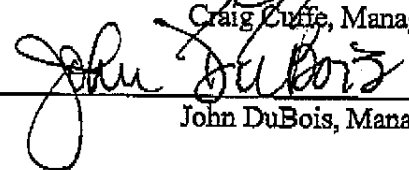
The total number of membership units authorized to be issued by the Company shall be 1,000,000 units, with 500,000 units to be voting units and 500,000 units to be non-voting units. Any membership unit not specifically designated as non-voting shall be a voting unit. Each voting unit shall entitle the holder thereof to one (1) vote at any meeting of the members. All or any part of the membership units may be paid for in cash, in property, or in labor or services at a fair valuation to be fixed by the Managers of the Company at a meeting called for such purposes. All membership units then issued shall be paid for and shall be nonassessable. The Company elects to have preemptive rights, governed in accordance with Section 607.0630 of the Florida Statutes.
