MANAGEMENT OF COMPANY

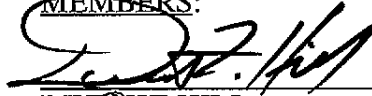

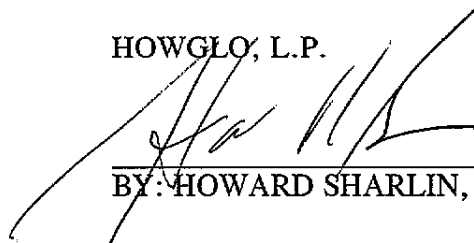

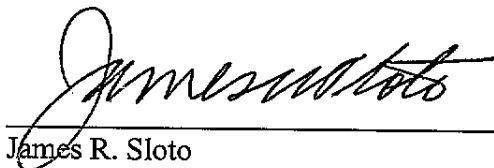
