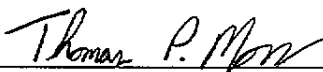

This Limited Liability Company shall be deemed to have come into existence on the date these Articles of Organization are executed.

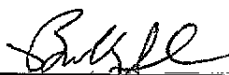
