## ARTICLES OF ORGANIZATION

OF

(A Florida Limited Liability Company)

- 1. The date of the filing of the Articles of Organization was May 11, 2001.
- following 2. The Amendment(s) the Articles of Organization were adopted by the Limited Liability Company.

Paragraph 11 is hereby amended to indicate that the sole Member of this Limited Liability Company shall be Really Big Limo Bus, Ltd., a British Virgin Islands Corporation and as such Really Big Limo Bus shall own one (100%) percent of the member interest in Big Limo Bus, LLC.

Paragraph 12 is added to the Articles of Organization as follows:
