TO
ARTICLES OF ORGANIZATION
OF

BIG LIMO BUS, LLC
(A Florida Limited Liability Company)

1. The date of the filing of the Articles of Organization was May 11, 2001.

2. The following Amendment(s) to the Articles of Organization were adopted by the Limited Liability Company.

Paragraph 11 is hereby amended to indicate that the sole Member of this Limited Liability Company shall be Really Big Limo Bus, Ltd., a British Virgin Islands Corporation and as such Really Big Limo Bus shall own one (100%) percent of the member interest in Big Limo Bus, LLC.

Paragraph 12 is added to the Articles of Organization as follows:

"12. Profits. All the net profits (the "Profits") of this Limited Liability Company shall be divided between (i) Murrel Sean Scarborough, as to forty-five (45%) percent of the Profits, (ii) Really Big Limo Bus, LLC, a British Virgin Islands Corporation, as to forty-five (45%) percent of the Profits and (iii) Dina Palermo as to ten (10%) percent of the Profits.



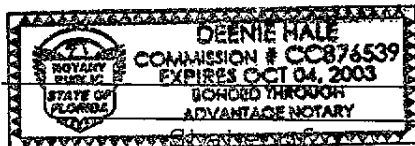
