ARTICLES OF ORGANIZATION FOR IBID FT. LAUDERDALE, L.L.C. (FROM THIS DAY FORWARD TO BE NAMED FT. LAUDERDALE, L.L.C.)

A LIMITED LIABILITY COMPANY

KNOW ALL MEN BY THESE PRESENTS: That the undersigned,

pursuant to the provisions of the Florida Business Corporation Act, adopts the following Amended and Restated Articles of Organization, which amendments to the Company's Articles of Organization, as amended, contained therein were adopted by the managing members on October 3, 2002, and the number of shares adopting the Amended and Restated Articles of Organization by such group was sufficient for approval.

ARTICLE I - Name

The name of the Limited Liability Company is: Ft. Lauderdale, L.L.C., a limited liability company (the "Company").

ARTICLE II - Address
