# ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

### ZeBRANEK PAIN CLINIC, L.L.C.

FIRST: The date of filing of the Articles of Organization was May 14, 2001.

**SECOND**: The following amendments to the Articles of Organization were adopted by the limited liability company:

#### ARTICLE I - NAME

The name of the limited liability company is ZeBRANEK PAIN CLINIC, L.L.C.

#### ARTICLE II - PURPOSE
