**ARTICLES OF ORGANIZATION
OF
MK INDUSTRIES, L.L.C.**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida does set forth the following:

ARTICLE I – NAME

The name of the Limited Liability Company is: MK Industries, L.L.C., referred to in these Articles of Organization as the “Company.”

ARTICLE II – PERIOD OF DURATION

Unless dissolved earlier, the Company will dissolve automatically on May 1, 2031. Except for prior amendment to this article II, no act by the Company or its members can avoid that dissolution.

ARTICLE III – PURPOSE

The purpose for which the Company is organized is to engage in the operation of a machine shop. The Company shall also have all of the other powers vested in a limited liability company organized and existing under the laws of the State of Florida.

ARTICLE IV – ADDRESS OF PLACE OF BUSINESS

The mailing address and the street address of the principal office of the Company is: 5613 8th Street SW, Lehigh Acres, Florida 33971.

ARTICLE V – REGISTERED AGENT

ARTICLE VI – ADDITIONAL MEMBERS

Members may admit additional members upon the majority vote of the then existing members.

ARTICLE VII – CONTINUITY OF BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall not be continued and the Company shall be dissolved unless there is obtained the consent of a majority of the remaining members of the Company, as more particularly provided by the Company's regulations.

The Company is organized as a single entity L.L.C. The sole member of the Company, with one hundred percent (100%) interest in the Company, is Michael Eric Kirkendoll.


