ARTICLES OF ORGANIZATION FOR WASHINGTON AV. MAGAZINE, L.L.C.

ARTICLE I NAME

The name of the Limited Liability Company is WASHINGTON AV. MAGAZINE, L.L.C.

ARTICLE II ADDRESS
