

**ARTICLES OF ORGANIZATION
OF
ICAUGHTYOU, L.L.C.**

The undersigned sole member ("Member"), for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - Name

The name of the Limited Liability Company is ICaughtYou, L.L.C. ("Company").

ARTICLE II - Address

The mailing address and street address of the principal office of the Company shall be 24850 Old U.S. 41 Road, #23, Bonita Springs, Florida 34135.

ARTICLE III - Duration

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The period of duration of the Company shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV - Purpose

The Company is formed for the object and purpose of, and the nature of the business to be conducted and promoted by the Company is, engaging in any lawful act or activity for which limited liability companies may be organized under the laws of the State of Florida.

ARTICLE V - Management

The Company shall be managed by the Member in accordance with the regulations adopted by the Member for the management of the business and affairs of the Company and the name and address of the managing member is Stellar Business Builders, L.L.C., 24850 Old U.S. 41 Road, #23, Bonita Springs, Florida 34135. ARTICLE VII - Dissolution

The Company shall be dissolved and its affairs shall be wound up upon the first to occur of the following: (a) the written consent of the Member or (b) the resignation, bankruptcy or dissolution of the Member or the occurrence of any other event which terminates the continued membership of the Member in the Company.

ARTICLE VIII - Registered Office and Agent

ARTICLE IX - Capital Contribution

The Member has contributed \$1,000 in cash, and no property, to the Company.

ARTICLE X - Additional Capital Contributions

The Member may, but is not required to, make any additional capital contribution to the Company.

ARTICLE XI - Indemnification

The Company may indemnify any manager, employee or agent of the Company to the full extent permitted by law.
