The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, does hereby adopt the following articles of organization:

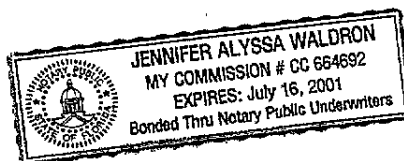


