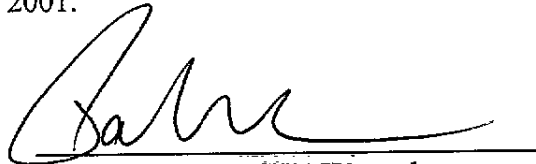

These Articles of Organization may be amended in any manner now or hereafter provided for by law, and all rights conferred upon Members hereunder are granted subject to this reservation.

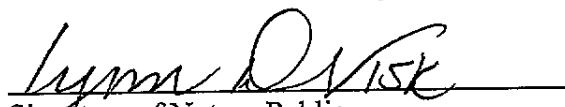

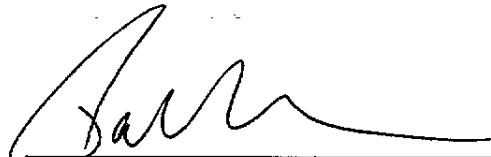
