ARTICLES OF ORGANIZATION
OF
WHITE LAKE INVESTMENTS, LLC

Pursuant to Chapter 608 of Florida Statutes, the undersigned do hereby certify that we have associated ourselves for the purpose of doing business as a Limited Liability Company under the laws of Florida, and do hereby further certify that the following are our Articles of Organization:

1. The name of the Limited Liability Company is **White Lake Investments, LLC**, and is hereinafter sometimes referred to as the "Company."

2. The period of duration of this Limited Liability Company shall be from the time and date these Articles are filed with the Florida Department of State until December 31, 2035, however, by unanimous consent of the Members, the duration may be extended for such time as the Members specify.

3. The mailing address and street address of the principal office of the Limited Liability Company is 2666 Airport Road South, Naples, Florida 34112.

4. The company shall have for its initial registered agent Brad Black, whose mailing and street address is 2666 Airport Road South, Naples, Florida 34112. Acceptance of said position is reflected in the Certificate of Designation of Registered Office and Registered Agent that accompanies these Articles of Organization.

5. The members shall have the right to admit additional members only upon the unanimous consent of the members.

6. On the death or resignation of a Member, or upon the happening of any other event which terminates the continued membership of a member, the remaining members shall have the right to continue the business of the company.

7. The Limited Liability Company is to be managed by its members, and the names and addresses of its two initial members are:

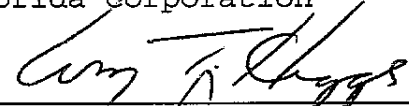

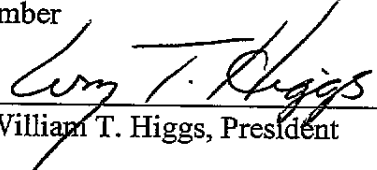
