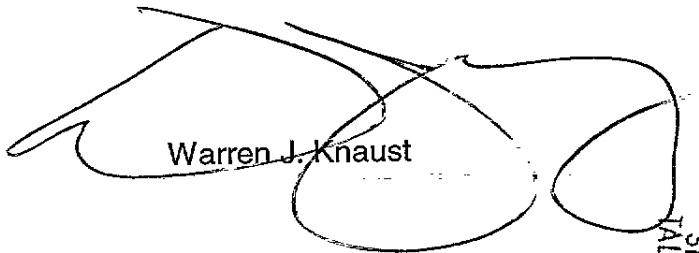

Articles of Organization for  
**ACME COMPANY, L.C.**

a Florida Limited Liability Company

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

1. Name. The name of this company shall be ACME COMPANY, L.C.
2. Duration/Continuation. The period of this company's duration shall be twenty (20) years, unless terminated by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member, unless the business of the company is continued by the consent of all the remaining members, or by amendment of these Articles of Organization providing for the continued existence of the company subsequent to the foregoing events.
3. Address. The mailing and street address is 2730 Central Avenue, St. Petersburg, Florida 33712.
4. Registered Agent and Office. The name and street address of the initial registered agent and office for this company is as follows: Warren J. Knaust, Esq. 2730 Central Avenue, St. Petersburg, Florida 33712.
5. Admission of Additional Members; and Terms and Conditions of such Admissions. Additional Members may be admitted upon the approval of a majority of the Members of the Company, or by the consent of the Managerial Members named in Paragraph 7 below, upon the written application of such new Member, in the manner set forth in the Bylaws of this Company.
6. Right to Continue Business. The remaining members may continue the Business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the company.
