#### AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF

BARRINGTON PLACE, L.L.C.

- 1. The current name of the Company is BARRINGTON PLACE, L.L.C.
- The Company was originally formed under the name BARRINGTON WOODS, f.J.C.
- 3. The original Articles of Organization were filed with the Department of State on May 18, 2001.
- 4. Articles of Amendment to the Articles of Organization changing the name to BARRINGTON PLACE, L.I..C. were filed on June 7, 2001.
- 5. These Amended and Restated Articles of Organization shall become effective upon filing.
- 6. These Amended and Restated Articles of Organization have been duly executed and are being filed in accordance with Section 608.411, Florida Statutes.
- 7. The Company amends and restates in its entirety the Articles of Organization of the Company to read as follows:

#### ARTICLE I NAME

The name of this limited liability company is VILLA SAN MARCO PARTNERS, LLC.

#### ARTICLE II DURATION

The Company's duration shall be perpetual unless sooner dissolved.
