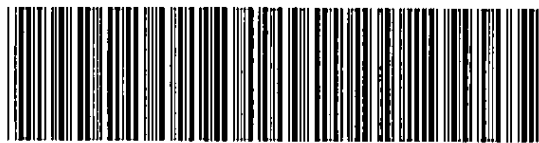

**SECOND:** The following amendment to the Articles of Organization was adopted by the limited liability company:


