FIRST: The name of the Limited Liability Company is Maguire Executive Hotel Group, LLC.

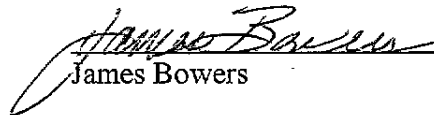

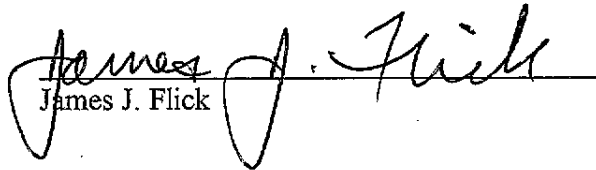
