ARTICLES OF ORGANIZATION OF MEDICAL INJURY ASSOCIATES, LLC

ARTICLE I NAME

The name of the limited liability company is Medical Injury Associates, LLC (the "Company").

ARTICLE II ADDRESS

ARTICLE III DURATION AND CONTINUATION

The Company's existence will commence upon the filing of these Articles with the Florida Department of State, and the Company will exist perpetually, unless terminated in accordance with the Company's Operating Agreement.

ARTICLE IV PURPOSE

The purpose for which the Company is being formed is to engage in any activity business permitted under the laws of the United States and of the State of Florida.

ARTICLE V REGISTERED AGENT AND REGISTERED OFFICE AND REGISTERED AGENT'S SIGNATURE

The Company designates 37 North Orange Avenue, Suite 500, Orlando, Florida 32801, as the street address of the initial registered agent of the Company and Robert G. Clements as the initial registered agent at that address to accept service of process within this state.

I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, Florida Statutes.

ARTICLE IX OPERATION AGREEMENT

The power to adopt, alter, amend, or repel the Operating Agreement of the Company will be with the members of the Company.
