Article III - Duration





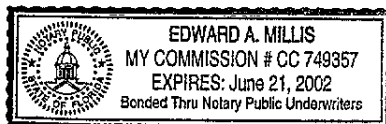
