**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION

OF

KVN, LLC**

The undersigned person, acting as the sole member and managing member of KVN, LLC, a Florida limited liability company, under §608.411 of the Florida Limited Liability Company Act, Florida Statutes, adopts the following Amended and Restated Articles of Organization to the Articles of Organization of KVN, LLC, previously filed with the Florida Department of State on May 21, 2001:

ARTICLE I - NAME

The name of this limited liability company is:

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence on the date these Articles of Organization are filed with the Florida Department of State, and the existence of the company shall be perpetual.

ARTICLE III - PURPOSE

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The right of the members to admit additional members and the terms and conditions of the admissions shall be restricted solely to those members approved by the written consent of all of the then-existing members and upon such terms and conditions as shall be set forth in its regulations.

ARTICLE VII - MANAGEMENT BY MEMBERS

The business of the company shall be managed by its members in accordance with the terms and conditions set forth in the company's regulations.

ARTICLE VIII - REGULATIONS

The power to adopt, alter, amend, or repeal the regulations of the company is vested exclusively in the members of the company.

ARTICLE IX - APPROVAL

These amended and restated Articles of Organization were duly authorized and approved by the sole member and managing member of the company.

ARTICLE X - TERMINATION OF A MEMBERSHIP INTEREST

The company shall not be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the company.
