## MEMBERSHIP

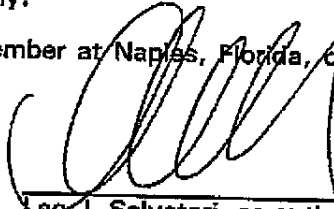
