**ARTICLES OF ORGANIZATION**  
**OF**  
**NEW WORLD LEARNING CENTER, LLC**

I, the undersigned, for the purpose of forming a limited liability company pursuant to the Florida LLC 'Act', a natural person of the age of 18 years or more, acting as an organizer of a Limited Liability Company (the "Company") adopt the following Articles of Organization for the Company.

**ARTICLE ONE**

**NAME.** The name of the Limited Liability Company shall be **NEW WORLD LEARNING CENTER, LLC**, a Florida Limited Liability Company, and the officers shall be authorized to designate appropriate fictitious names for the Company as appropriate.

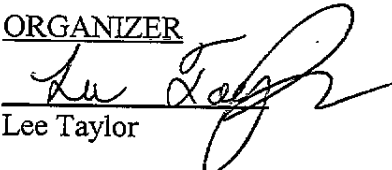

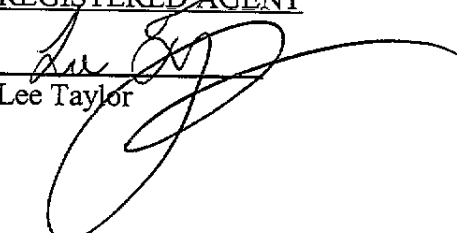
