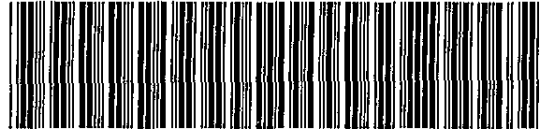

FIRST: The date of filing of the Articles of Organization was May 22, 2001

SECOND: The following amendment(s) to the Articles of Organization were adopted by the limited liability company:

ARTICLE I of the Articles of Organization is hereby amended to reflect the following name change:

The name of the Florida limited liability company is changed from Zorrilla & Associates, LLC, to Zorrilla & Robin, LLC., effective as of June 15, 2003
