1. Pursuant to Florida Statutes Sections 608.411, the Articles of Organization of the above-referenced Limited Liability Company is amended in accordance with the following:


FIRST: The date of filing of the articles of organization was May 22, 2001, effective May 17, 2001, under document number L01000008141.
