
Article V. Management

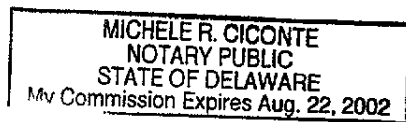


