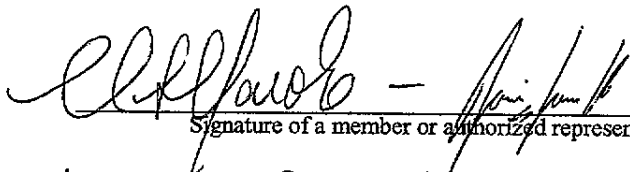
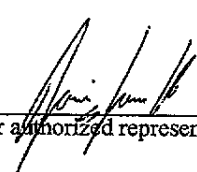
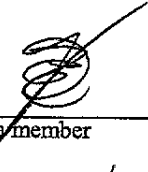
**FIRST:** The date of filing of the articles of organization was May 23rd, 2001.
