# ARTICLES OF ORGANIZATION

## OF

### JUNIOR CHAMPIONS TOUR LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1 - NAME

The name of the limited liability company shall be **JUNIOR CHAMPIONS TOUR LLC**, ("Company").


