The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I — Name:**

The name of the limited liability company (hereinafter referred to as the "Company") is "GEORGETOWN ENTERPRISES, LLC."

**ARTICLE II — Address:**
