ARTICLES OF ORGANIZATION OF WIRELESS USA...FOR MORE TALK, LLC

Under the Florida Limited Liability Company Act

ARTICLE I NAME

The name of this limited liability company is Wireless USA...For More Talk, LLC (hereinafter "the Company").

ARTICLE II MAILING AND STREET ADDRESS

No Member of the Company has the right to withdraw or reduce his capital contribution to the Company except upon the written consent of majority of the members.

ARTICLE X BUSINESS PURPOSE
