ARTICLES OF ORGANIZATION

OF

KENICAHN, LLC

Pursuant to the Florida Limited Liability Company Act, Chap. 608, Florida Statutes (1995), as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I.
NAME**

The name of this limited liability company (the "Company") shall be KENICAHN, LLC.

**ARTICLE II
DURATION**

Unless earlier terminated pursuant to the Act or the regulations (as defined in §608.402(13) of the Act) of this Company, the period of its duration shall be performed.

Pursuant to §608.407(1)(f), Florida Statutes, the remaining member of this Company shall have the right to continue the Company's business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of the member in this Company.

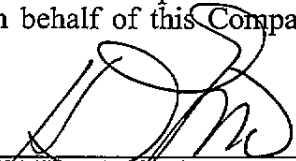

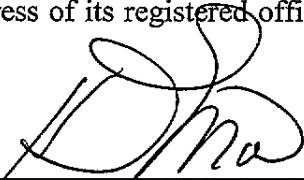

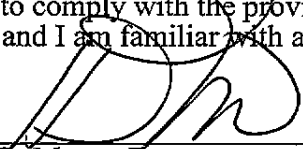
