**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I. NAME

The name of the limited liability company shall be PDT INVESTMENTS #2, LLC, hereinafter referred to as the "Company"

ARTICLE II. DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall terminate not later than seventy five (75) years from the date that these Articles Of Organization are filed with the Florida Department of State, unless the Company is earlier dissolved as provided in these Articles of Organization, the operating agreement, or as provided in Chapter 608, Florida Statutes (1999)

ARTICLE IV. - REGISTERED OFFICE AND AGENT

ARTICLE V. - ADMISSION OF ADDITIONAL MEMBERS


ARTICLE VIII. - MANAGEMENT
