

**ARTICLES OF ORGANIZATION
OF

ARTICLE VI - Admission of Additional Members


A person may be admitted as an additional member only upon the written consent of a majority of the voting power of the then members of the Company.



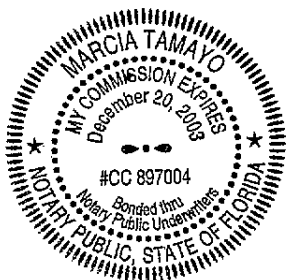
