ARTICLES OF ORGANIZATION OF STERNSTEIN, RAINER & CLARKE, P.L.

The undersigned, for the purpose of forming a limited liability company under the Florida Professional Limited Liability Company Act, F.S. Chapters 608 and 621, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME & PURPOSE
