ARTICLES OF ORGANIZATION
OF
STERNSTEIN, RAINER & CLARKE, P.L.

The undersigned, for the purpose of forming a limited liability company under the Florida Professional Limited Liability Company Act, F.S. Chapters 608 and 621, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME & PURPOSE

The name of the professional limited liability company shall be Sternstein, Rainer & Clarke, P.L. ("company"). The sole and specific purpose of the company is to engage in every phase and aspect of the practice of rendering professional services as attorneys at law. In addition, the company may invest the funds of the professional service company in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be 101 North Gadsden Street, Tallahassee, FL 32301

ARTICLE III -- DURATION

The company shall commence its existence on July 1, 2001. The company's existence shall be perpetual unless the company is earlier dissolved.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is Gary Clarke, 101 North Gadsden Street, Tallahassee, FL 32301

ARTICLE V -- ADMISSION OF NEW MEMBERS;
RESTRAINT ON ALIENATION OF SHARES

The members of the company shall only be professionals duly authorized to practice law in the State of Florida. No shareholder of the company may sell or transfer his/her interest in the company except to another individual who is eligible to be a member of the company, and the sale or transfer may be made only after it has been approved at a member meeting especially called for that purpose as described in the regulations. If any member becomes legally disqualified to practice law in the state of Florida, is elected or appointed to a public office, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services, that member's interest shall immediately become subject to purchase by the company in accordance with the regulations adopted by the members.

ARTICLE VI -- TERMINATION OF EXISTENCE

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members, provided there are at least two remaining members.
