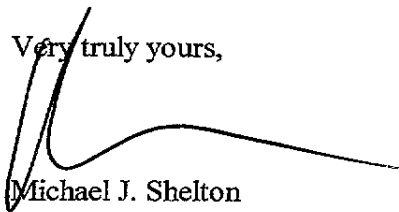

ARTICLES OF ORGANIZATION
of
ET INVESTMENTS, LLC

A Florida Limited Liability Company

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be:

ARTICLE II - ADDRESS

ARTICLE III - PURPOSE AND POWER

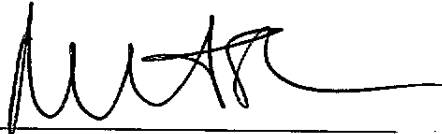

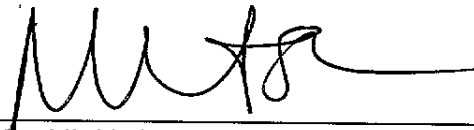
