**ARTICLE I  
Name**

The name of the limited liability company ("Company") is OMBRA L.C.

**Admission of New Members**

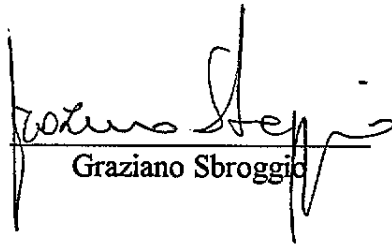

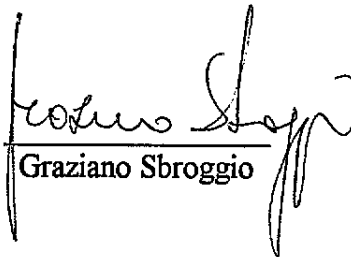
**CERTIFICATE OF DESIGNATION OF
