ARTICLES OF ORGANIZATION OF OMBRA L.C.

ARTICLE I Name

The name of the limited liability company ("Company") is OMBRA L.C.

ARTICLE II Address

The mailing address of the Company is 721 Lincoln Road, Miami Beach, Florida 33139, and the address of the Company's principal place of business is 2305 Ponce de Leon Boulevard, Coral Gables, Florida 33134.

ARTICLE III Duration

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV Registered Agent and Office

The name of Company's initial registered agent in Florida is Graziano Sbroggio. The address of Company's registered office in Florida is 721 Lincoln Road, Miami Beach Florida 33139.

ARTICLE V Management

The Company is to be managed by one manager or more managers and is, therefore, a manager-managed company. The initial manager will serve until the first annual meeting of the members. The initial manager is identified as follows:

Graziano Sbroggio, whose address is 721 Lincoln Road, Miami Beach, Florida 33139.

ARTICLE VI Admission of New Members

Members of the Company have the right to admit new members, provided that additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time new members are admitted.

ARTICLE VII Continuation of Business

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.
