ARTICLES OF ORGANIZATION
OF
CREATIVE BENEFITS ADMINISTRATIVE SERVICES, LLC

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

ARTICLE I

Name and Address of Company

The name of the limited liability company (hereinafter referred to as the "Company") is Creative Benefits Administrative Services, LLC. The Company's street address and mailing address is 1220 East Park Avenue, Tallahassee FL 32301.

ARTICLE II

Commencement and Duration of Company

The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified in Section 608.441, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III

Management

The following persons shall serve as the Company's initial managers until the first annual meeting of the membership or until their successors are elected and qualified are:

and,

Business Manager - Lucia Lightfoot, 1220 East Park Avenue, Tallahassee FL 32301.

Thereafter, the Company will be managed by a manager or managers elected annually, as provided in the Company's regulations.

ARTICLE IV

Admission of Additional Members

Additional members may be admitted to the Company if all the current members agree to the admission of the additional members and to the terms of such admission.

Registered Agent and Office


