

ARTICLES OF ORGANIZATION

ARTWORK UNLIMITED, LLC



ARTICLE I

Name and Address of Company

The name of the limited liability company (hereinafter referred to as the "Company") is Artwork Unlimited, LLC. The Company's street address and mailing address is 17532 N.W. 61st Street, Hialeah FL 33015.

ARTICLE II

Commencement and Duration of Company

The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified in Section 608.441, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III

Management

The following person shall serve as the Company's initial manager until the first annual meeting of the membership or until his successor in elected and qualified: Lewis & White, L. C., 222 West Georgia Street, Tallahassee FL 32301. Thereafter, the Company will be managed by a manager or managers elected annually, as provided in the Company's regulations.

ARTICLE IV

Admission of Additional Members

Additional members may be admitted to the Company but only if all the current members agree to the admission of the additional members and to the terms of such admission.

ARTICLE V

Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, declared insane becomes bankrupt, is dissolved or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, unanimous written agreement, continue the business of the Company.

ARTICLE VI

Registered Agent and Office

ARTICLE VII

Operating Agreement and Regulations

The members of the Company have the power to adopt, alter, amend, or repeal the operating agreement and regulations of the Company containing provisions for the regulation and management of the affairs of the Company.
