**ARTICLES OF ORGANIZATION
OF
KATALYX TRANSPORTATION SPAIN, LLC**

ARTICLE I

The name of the limited liability company (hereinafter called the "limited liability company") is KATALYX TRANSPORTATION SPAIN, LLC.

ARTICLE II

The mailing address and the address of the principal office of the limited liability company is 1221 Brickell Avenue, 12th Floor Miami, FL, 33131.

ARTICLE III

The period of duration for the limited liability company shall be perpetual.

ARTICLE IV

Additional members may be admitted and the terms and condition of such admissions shall require the vote of all existing members, and shall be conditioned on the new member's agreement to abide by all existing agreements of the members regarding the conduct of the Company.

ARTICLE V




