


ARTICLE III



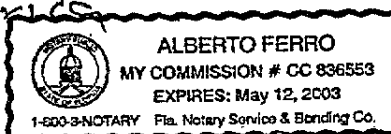
