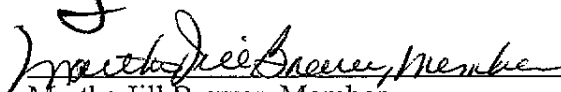
**ARTICLE III

This limited liability company will be a manager-managed company.

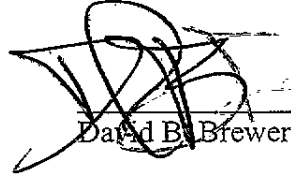
