ARTICLE I. The name of the limited liability company is OUTER SPACE DESIGN COMPANY, LLC.

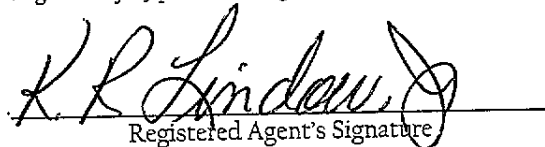
